## RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 54-75

WHEREAS, William E. Strickland was by Council Resolution No. 54-73, retained as general counsel to represent the Papago Tribe 2 3 under an Attorney's Contract, Contract No. H50C14208711. for a period of two years, starting September 24, 1973 and September 24, 1975; and 5 WHEREAS, at the time said Attorney's Contract was negotiated 6 neither the Tribe nor William E. Strickland could accu-7 8 rately estimate the amount of time or legal expenses 9 which would be required to represent the Tribe, and con-10 sequently the Contract provided that the Tribe would be 11 billed at the rate of \$35.00 per hour for legal services 12 rendered in excess of the seventy (70) hours per month 13 covered by the monthly retainer; and 14 WHEREAS, in order to set a fixed estimate for attorney's fees and 15 expenses to be included in the Tribe's general budget. 16 limitations were set in the Contract of \$40,000 per year 17 for legal services and of \$6,000 per year for expenses; 18 and : 19 WHEREAS. for years prior to the aforesaid Attorney's Contract the 20 cost of legal services substantially exceeded such fixed 21 annual limitations and the services of the Tribe's gen-22 eral counsel were covered, not by a single contract, but 23 various multiple contracts; and 24 WHEREAS, by Resolution No. 70-73, this Council directed that 25 William E. Strickland and his associates be employed 26 under and pursuant to the Attorney's Contract to repre-27 sent not only the Council, but any and all chartered and 28 subordinate organizations and corporations of the Papago 29 Tribe and Council; and this Council did review said Attorney's Contract on June 30 WHEREAS. 31 25, 1975, and, anticipating that the Tribe's need for 32 legal services would exceed the original estimate by at

least one thousand hours per year, increased the maximum annual fee to \$75,000; and

WHEREAS, over the past year the Tribe did or will require the legal services of its general counsel in excess of the latter estimate, and it presently estimated that the Papago Tribe will require approximately three thousand hours of legal services during the contract year; and over the past year the need for and the cost of legal WHEREAS, expenses has increased and it will be necessary to increase the \$6,000 limitations for such expenses set in the Attorney's Contract.

12 NOW, THEREFORE, BE IT RESOLVED that the SEVENTY-FIVE THOUSAND DOL LARS (\$75,000) amended maximum fee set in the Attorney's Contract with William E. Strickland is hereby changed to ONE HUNDRED THOUSAND DOLLARS (\$100,000) expenses limitations is changed to SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$7,500), and said Contract is hereby amended to reflect such changes.

The foregoing Resolution was duly enacted by the Papago Council on the 25th day of July, 1975, at a meeting at which a quorum was present with a vote of 834.0 for, 0 against, 0 not voting and o absent, pursuant to authority vested in the Papago Council by Section 2(b) and Section 3(a) and (h) of Article V of the Consti-24 tution and By-laws of the Papago Tribe of Arizona ratified by the 25 Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (48 Stat: 984) pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
