

RESOLUTION OF THE PAPAGO COUNCIL

RES.NO. 78-75

1 WHEREAS, the Papago Tribe has retained William E. Strickland of the law firm  
2 of Strickland and Altaffer since September 24, 1973, under Contract  
3 No. H50C14208711, which said Contract was amended by Council Resolutions  
4 No. 21-74 and No. 54-75; and  
5 WHEREAS, William E. Strickland's contract expires on the 24th of September, 1975  
6 and Mr. Strickland has performed his duties under said contract profi-  
7 ciently and competently; and  
8 WHEREAS, it is the desire of the Papago Tribe to retain the law firm of Stricklan  
9 and Altaffer as General Counsel for an additional two-year period.  
10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the law firm of  
11 Strickland and Altaffer be employed by the Papago Tribe under and  
12 pursuant to the terms of the attached Attorney's Contract (General  
13 Counsel), and any amendments or extensions thereof, and the Chairman  
14 and Secretary of the Papago Council are hereby authorized and directed  
15 to execute said Contract for and on behalf of the Papago Tribe.  
16 The foregoing Resolution was duly enacted by the Papago Council on the 25th  
17 day of September, 1975, at a meeting at which a quorum was present with a vote  
18 of 834.0 for; 0 against; 0 not voting; and 1 absent, pursuant to  
19 authority vested in the Papago Council by Section 2 (b) and Section 3 (a) and  
20 (h) of Article V of the Constitution and By-laws of the Papago Tribe of  
21 Arizona, ratified by the Papago Tribe on December 12, 1936, and approved by the  
22 Secretary of the Interior on January 6, 1937, (48 Stat. 984) pursuant to  
23 Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the  
24 date of its approval by the Superintendent of the Papago Agency and is subject  
25 to review by the Secretary of the Interior.
