RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 79-75

WHEREAS, members of the Papago Tribe residing in the villages of Managers Dam, Gu Vo, Hickiwan, Charco 27, Vaya Chin, Ventena and Ka Ka on the Papago Indian Reservation are without U. S. mail or postal services; and

WHEREAS, residents of said villages have filed signed petitions with the U.S. Postal Service asking for such services; and

WHEREAS, as citizens of the United States the residents of said villages should be entitled to such services,

NOW, THEREFORE, BE IT RESOLVED that the Papago Council requests the United States Postal Service to provide U. S. mail and postal services to the villages of MANAGERS DAM, GU VO, HICKIWAN, CHARCO 27, VAYA CHIN, VENTENA and KA KA on the Papago Indian Reservation.

BE IT FURTHER RESOLVED that Cecil Williams, Chairman of the Papago Council and/or William E. Strickland, general counsel for the Papago Tribe, are hereby authorized and directed to perform all acts necessary to give effect to this Resolution.

The foregoing Resolution was duly enacted by the Papago Council on the 8th day of October ,1975, at a meeting at which a quorum was present with a vote of 834.0 for; 0 against; 0 not voting; and absent, pursuant to authority vested in the Papago Council by Section 2 (a) of Article V of the Constitution and By-laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937 (48 Stat. 984) pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency, and is not subject to review by the Secretary of Interior.
