

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 11-77

1 WHEREAS, Frances Ray has resigned as Chairperson and as a member of  
2 the Board of Commissioners of the Papago Housing Authority;  
3 and

4 WHEREAS, the Papago Tribal Council, with the consent of the Hicikiwan  
5 District Council, has agreed to remove Irene Maxfield as a  
6 member of the said Board because of nonattendance at the  
7 Board meetings; and


8 WHEREAS, Article IV of the Ordinance establishing the Papago Housing  
9 Authority provides that the Papago Council shall appoint  
10 and/or re-appoint Board members, and shall name one of the  
11 Commissioners, within the Board, as Chairperson.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Larry  
13 Garcia and Melinda Manuel are hereby appointed as members  
14 of the Board of Commissioners of the Papago Housing Authority.

15 BE IT FURTHER RESOLVED that Larry Garcia is hereby named as Chair-  
16 person of the Board of Commissioners of the Papago Housing  
17 Authority.

18 The foregoing Resolution was duly enacted by the Papago Council on  
19 the 4th day of February, 1977, at a meeting at which a quorum was  
20 present with a vote of (see attached voting record); pursuant to the  
21 authority vested in the Council by Section 2 (e) and (f) of Article  
22 V of the Constitution and By-laws of the Papago Tribe as amended,  
ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
not subject to review by the Secretary of the Interior and is effective  
as of the date of its enactment by the Papago Council.
