

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 1-77

1 WHEREAS, Section 2 of Chapter I of the Law and Order Code provides
2 for the appointment of Judges of the Papago Tribal Courts
3 by the Commissioner of Indian Affairs, subject to confir-
4 mation by a majority vote of the Papago Council; and
5 WHEREAS, such appointment is for a maximum term of two years; and
6 WHEREAS, Mable Antone was in 1972 appointed as Judge of the Papago
7 Tribal Court, and was in 1974 re-appointed for a second
8 two-year term, which expired in 1976; and
9 WHEREAS, it is the recommendation of the Papago Council that SARAH
10 CORELLA be appointed as Judge for a two-year term.
11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that "it does
12 hereby recommend to the Commissioner of Indian Affairs
13 appointment of SARAH CORELLA, and does confirm such
14 appointment as Judge of the Papago Tribal Court, and does
15 hereby direct that Mable Antone shall continue in her
16 office as Judge de facto, until such appointment becomes
17 effective.

18 The foregoing Resolution was duly enacted by the Papago Council on
19 the 7th day of January, 1977, at a meeting at which a quorum was
20 present (see attached voting record), pursuant to the authority
21 vested in the Council by Section 2 (e) and (f) of Article V of the
22 Constitution and By-laws of the Papago Tribe as amended, ratified
23 by the Papago Tribe on December 12, 1936, and approved by the
24 Secretary of the Interior on January 6, 1937, pursuant to Section
25 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
26 not subject to review by the Secretary of Interior and is effective
27 as of the date of its enactment by the Papago Council.
