

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 18-77

1 WHEREAS, the San Xavier District Cooperative, Inc., has had the use
2 of a trailer, No. 102 (known as Project No. 10232), located
3 at San Xavier Cooperative, Inc., for administration meeting
4 room and office, which trailer is owned by the Bureau of
5 Indian Affairs; and

6 WHEREAS, the Bureau of Indian Affairs is willing to transfer owner-
7 ship of said trailer to the Papago Tribe.

8 NOW, THEREFORE, BE IT RESOLVED that the Tribal Chairman and/or other
9 Tribal officials be authorized to acknowledge receipt for
10 said trailer on behalf of the Papago Tribe; and

11 BE IT FURTHER RESOLVED that the San Xavier Cooperative, Inc., be
12 authorized to continue its present use and occupancy of said
13 trailer for an undesignated period of time provided it
14 assumes all responsibilities for trailer upkeep, maintenance
15 and repair.

16 The foregoing Resolution was duly enacted by the Papago Council on
17 the 4th day of March, 1977, at a meeting of which a quorum was present
18 with a vote of 834.0 for; 0 against; 0 not voting; and 0 absent, pur-
19 suant to authority vested in the Council by Section 2 (a) and 3 (h)
20 of Article V of the Constitution and By-laws of the Papago Tribe, as
21 amended, ratified by the Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
not subject to review by the Secretary of Interior and is effective
as of the date of its enactment by the Papago Council.
