RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 30-77

WHEREAS, the Papago Tribe has been advised by the Federal Aviation Administration of the Department of Transportation of its intention to establish a Low 2 3 Military Operations Area over the Sells Papago Reservation as part of a national program which would use such area for military aircraft activities, 4 5 including basic aircraft handling techniques, tactical formation flight 6 control techniques, low altitude visual/radar aerial navigation, at the 7 vertical dimensions of 100 feet Above Ground Level up to 10,000 feet 8 above Mean Sea Level; and 9

WHEREAS, the Papago Council has repeatedly objected to the intrusion of military aircraft over the airspace of the Papago Reservation; to the low level flights over its roads, buildings and schools which have frightened and continue to frighten its children, people and livestock; and to the sonic booms resulting from such military aircraft operations which have caused and continue to cause damage to houses (particularly traditional adobe structures) and windows, and to interfere with the Papago peoples' quiet enjoyment of their lands and homes; and

WHEREAS, the Papago Council views the intention of the Federal Aviation Administration to establish a Low Military Operations Area over the Papago Sells Reservation as another attempt by a white society to deprive Indian people of the quiet enjoyment of some of their last remaining rights and assets, and to saddle Indian people and lands with the unbearable aspects of the white society.

NOW , THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby strongly object to the inclusion of the Sells Reservation, or any portion of the Papago Reservation into any Low Military Operations Area of the Federal Aviation Administration and hereby directs its Chairman, and any other Tribal Officers and its Attorneys to do everything necessary or appropriate to prevent and stop the contemplated and continuing trespass by military aircraft over the Papago Reservation.

The foregoing Resolution was duly enacted by the Papago Council on the 6th day of April, 1977, at a meeting at which a quorum was present with a vote of 834.0 for; O against; O not voting; and I absent, pursuant to authority vested in the Council
