RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 33-77

WHEREAS, ASARCO, Inc., formerly American Smelting and Refining Company, has made 1 application for water and gas pipe line and power line rights-of-way 2 over Tribal land within the San Xavier District of the Papago Reservation 3 described as follows: 4 5 The East 50 feet of the East Half of the Northeast (1)Quarter of Section 26, Township 16 South, Range 13 East, 6 7 and (2) the East 50 feet of the Southwest Quarter of 8 Section 26, Township 16 South, Range 13 East, G. & S.R.B. & M., 9 Pima County, Arizona; and 10 WHEREAS, the San Xavier District Council has consented to the grant of such 11 rights-of-way; and 12 WHEREAS, in the Settlement Agreement (Papago Tribe, et al., v. American Smelting 13 and Refining Company) entitled as "Cause No. CIV. 7-83 TUC", approved 14 November 9, 1971, under Section VI. B., it states: "The Papago Tribe, 15 and, as necessary, the other plaintiffs, shall, without further consid-16 eration, furnish to ASARCO all necessary water pipeline, powerline, and 17 roadway rights-of-way over lands owned by any of them across the Reservat 18 tion for operation of wells and the transportation of the water from the 19 well sites to the place of ASARCO's beneficial use, and shall assist 20 ASARCO in obtaining other rights-of-way as required from other indivi-21 dual allottees". 22 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that pursuant to Part 161 23 of Title 25 of the Code of Federal Regulations, it does hereby consent 24 to the grant of rights-of-way to ASARCO, Inc., across the above described 25 lands of the San Xavier Reservation for the construction, maintenance 26 and use of water and gas pipe lines and a power line without further 27 consideration for the grant of such rights-of-way. 28 The foregoing Resolution was duly enacted by the Papago Council on the 26th day 29 of May, 1977, at a meeting at which a quorum was present with a vote of <u>585.0</u> for 30 168.0 against; 81.0 not voting; and 4 absent, pursuant to the authority 31 vested in the Council by Section 2 (a) (c) and 3 (h) of Article V of the Consti-32 tution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe
