

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 39-77

1 WHEREAS, on May 4, 1977 the San Xavier District Council, by Resolution No. 04-77,
2 approved Tucson Gas & Electric Company's application for an overhead and
3 underground electrical distribution line right-of-way on the San Xavier
4 Reservation across the following described land:

5 Tribal Land (TR2) located in the SW $\frac{1}{4}$ of Section 23,
6 Township 15 South, Range 13 East, G&SRB&M, Pima
7 County, Arizona; and

8 WHEREAS, such a distribution line will be beneficial to the residents of the San
9 Xavier Reservation.

10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves
11 San Xavier District Council Resolution No. 04-77.

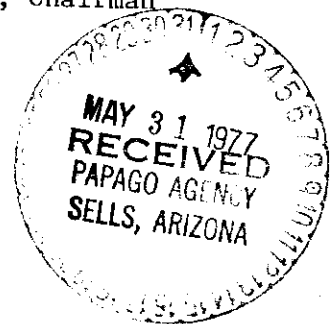
12 The foregoing Resolution was duly enacted by the Papago Council on the 26th day
13 of May, 1977, at a meeting at which a quorum was present with a vote of 834.0 for
14 0 against; 0 not voting; and 4 absent, pursuant to the authority
15 vested in the Council by Section 3 (k) of Article V of the Constitution and By-laws
16 of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936,
17 and approved by the Secretary of the Interior on January 6, 1937, pursuant to
18 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effec-
19 tive as of the date of its approval by the Superintendent of the Papago Agency and
20 is subject to review by the Secretary of Interior.
