

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 48-77

1 WHEREAS, the Papago Tribe did on Saturday, May 28, 1977, have a General Election
2 for the offices of Representatives and Alternates to the Papago Council,
3 and for the offices of Representatives and Alternates to the District
4 Councils; and

5 WHEREAS, the Papago Election Board did issue and post its Certificates of Election
6 Results in accordance with Section 4 (J) of Article VI of the Uniform
7 Election Ordinance, certifying to the election of the candidates who
8 received the highest number of votes for elective office; and

9 WHEREAS, under Section 4 (M) of Article VI of the Uniform Election Ordinance, it
10 is incumbent upon the Papago Council to issue Certificates of Election to
11 the candidates who received the highest number of votes for elective
12 offices to the Papago Council within 10 days after the Election Board has
13 posted its Certificates of Election Results unless an election contest
14 statement is filed within the time allowed and provided.

15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the Chairman and Secre-
16 tary of the Papago Council are hereby authorized and directed on behalf
17 of the Papago Council to execute and deliver a Certificate of Election
18 to the following persons elected from their respective Districts as Repre-
19 sentatives and Alternates to the Papago Council, who shall hold offices
20 for a term of four (4) years and until their successors are certified and
21 seated, to-wit:


The foregoing Resolution was duly enacted by the Papago Council on the 3rd day of June, 1977, at a meeting at which a quorum was present with a vote of 562.0 for; 63.5 against; 208.5 not voting; and 2 absent, pursuant to the authority vested in the Council by Section 2 (a) (c) and (f) of Article V of the Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of Interior and is effective as of the date of its enactment by the Papago Council.
