## RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 51-77

WHEREAS, the Papago Tribe in conjunction with the Bureau of Indian Affairs is providing judicial services; and 2 WHEREAS, the Judicial Department has a lack of office space; and 3 WHEREAS, the Judicial Department has had an increase in court cases; and 5 WHEREAS, the Judicial Department has had an increase in staff. 7 NOW, THEREFORE, BE IT RESOLVED that the Branch of Law Enforcement Services, Bureau of Indian Affairs, Papago Agency, purchase 8 a double wide mobile unit to supply the needs of the 9 10 Judicial Department. 11 The foregoing Resolution was duly enacted by the Papago Council on 12 the 12th day of July, 1977, at a meeting at which a quorum was present 13 with a vote of 809.5 for; 175.0 against; 80.5 not voting; and 1 absent, pursuant to authority vested in the Papago Council by 14 15 Section 2 (a) of Article V of the Constitution and By-laws of the 16 Papago Tribe of Arizona ratified by the Tribe on December 12, 1936, 17 and approved by the Secretary of the Interior on January 6, 1937, put 18 suant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 19 Resolution is not subject to review by the Secretary of Interior and 20 is effective as of the date of its enactment by the Papago Council. 21 THE PAPAGO COUNCIL 22 23 24 25 ATTEST: 26 27 28 MARY JANE JONES, 29 30 31
