

RESOLUTION TO THE PAPAGO TRIBAL COUNCIL

RES. NO. 53-77

1 WHEREAS, the Papago Tribe of Arizona is committed to the economic
2 development of Papago Land and the improvement of economic
3 life for its people; and

4 WHEREAS, the Papago Council has authorized participation in the
5 U. S. Department of Commerce, Economic Development Adminis-
6 tration program by establishing an overall Economic Develop-
7 ment Planning Committee and an EDA planning program; and

8 WHEREAS, it is the responsibility of the OEDP Committee to make an
9 overall Economic Development Plan for the improvement of
10 conditions and to present a list of action projects for the
11 consideration and prioritization of the Papago Council.

12 NOW, THEREFORE, BE IT RESOLVED that the Papago Council hereby approves
13 the projects on the attached list for development in the
14 order presented for submission to the Economic Development
15 Administration.

16 The foregoing Resolution was duly enacted by the Papago Council on
17 the 12th day of July, 1977, at a meeting at which a quorum was present
18 with a vote of 1011.0 for; 54.0 against; 0 not voting; and 1 absent.
19 pursuant to authority vested in the Papago Council by Section 2 (f)
20 of Article V of the Constitution and By-laws of the Papago Tribe
21 of Arizona ratified by the Tribe on December 12, 1936, and approved
22 by the Secretary of the Interior on January 6, 1937, pursuant to
23 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Reso-
24 lution is not subject to review by the Secretary of Interior and is
25 effective as of the date of its enactment by the Papago Council.
