

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 54-77

1 WHEREAS, Edward Tashquinth, an enrolled member of the Papago Tribe
2 and resident of Sells Village is desirous of better housing
3 and has applied for financing through Farmers Home Adminis-
4 tration; and

5 WHEREAS, a lot if needed to build a house on; and

6 WHEREAS, Mr. Tashquinth appeared before the Sells District Council
7 and requested a lot described herein; and

8 WHEREAS, at their meeting of March 3, 1977, the Sells District Council
9 did pass the attached Resolution approving the assignment
10 of said land to Mr. Tashquinth for use as a home site; and

11 WHEREAS, it is a Farmers Home Administration requirement that the
12 Tribal Council approve the assignment of said land to Mr.
13 Tashquinth and also that the Council authorize Mr. Tashquinth
14 to encumber the leasehold interest with a Farmers Home Admin-
15 istration approved mortgage.

16 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does
17 accept, approve and affirm the Sells District Council Reso-
18 lution.

19 BE IT FURTHER RESOLVED that pursuant to said Resolution it does
20 assign to Mr. Tashquinth that parcel of land lying with the
21 Papago Reservation and described as:

22 That Parcel of land lying in the Papago Indian
23 Reservation, Pima County, Arizona, described
as follows:

24 Beginning at the Southeast Corner of Section 25,
25 T-17-S, R-4-E, G.&S.R.B.&M.

26 Thence N53° 38' 47"E a distance of 2512.59 feet
to the True Point of Beginning;

27 Thence N05° 11' 55"E a distance of 152.00 feet
to a point;

28 Thence S84° 05' 05"E a distance of 151.00 feet
to a point;

29 Thence S05° 11' 05"W a distance of 152.00 feet
to a point;

30 Thence N84° 05' 05"W a distance of 151.00 feet
31 to the True Point of Beginning.

Containing in all 0.53 Ac.; and
BE IT FURTHER RESOLVED that said assignment shall be for use as a
homesite; and
BE IT FURTHER RESOLVED that it does authorize Mr. Tashquinth to
encumber the leasehold interest with a Farmers Home Admin-
istration approved mortgage; and
BE IT FURTHER RESOLVED that if Mr. Tashquinth should default in pay-
ment on said mortgage that the Sells District of the Papago
Tribe shall have first right to assume said mortgage and/or
to assign said mortgage to an eligible Papago resident of
the Sells District.


The foregoing Resolution was duly enacted by the Papago Council on
the 12th day of July, 1977, at a meeting at which a quorum was present
with a vote of 1065.0 for; 0 against; 0 not voting; and
1 absent, pursuant to authority vested in the Papago Council,
Article V, Section 2 (a) (c) & (m) and Article VIII, Section 3 (a) &
(b) of the Constitution and By-laws of the Papago Tribe of Arizona
ratified by the Tribe on December 12, 1936, and approved by the Secre-
tary of the Interior on January 6, 1934 (48 Stat. 984). Said Reso-
lution is effective as of the date of its approval by the Superinten-
dent of the Papago Agency and is not subject to review by the Secre-
tary of the Interior.


