WHEREAS, the Papago Housing Authority heretofore has entered into an Annual Con-1 tributions Contract with the Department of Housing and Urban Development 2 to develop fifteen (15) units of Conventional Mutual Help Housing desig-3 nated as Project No. AZ 26-9; and 4 WHEREAS, there has been no disapproval of the Project by the local governing body 5 or by members of the Papago Indian Community; and 6 7 WHEREAS, bids were received and opened May 24, 1977, at the time and place designated in the invitation for bids; and 8 WHEREAS, Joseph Construction Company was determined the lowest responsible bidder; 9 10 and WHEREAS, the Papago Housing Authority hereby selects and awards the contract to 11 12 Joseph Construction Company for Project AZ 26-9; and 13 WHEREAS, the selection of the Joseph Construction Company for Project AZ 26-9 by 14 the Papago Housing Authority shall be endorsed by the Papago Tribal Council, as requested by the Department of Housing and Urban Development. 15 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that endorsement is 16 17 given to the Papago Housing Authority for selection and award of contract 18 to Joseph Construction Company as contract for Project AZ 26-9. 19 BE IT FURTHER RESOLVED by the Papago Tribal Council that it hereby recommends 20 approval of Award of Contract to the Joseph Construction Company subject 21 to approval by the Department of Housing and Urban Development. 22 BE IT FURTHER RESOLVED by the Papago Tribal Council that it hereby authorizes the 23 Chairman or arthorized delegate, and the Secretary of the Tribal Council 24 to sign and execute the documents necessary to effectuate the develop-25 ment of said project. 26 The foregoing Resolution was duly enacted by the Papago Council on the 11th day of 27 August, 1977, at a meeting at which a quorum was present with a vote of 645.5 for; 28 108.0 against; 311.5 not voting; and 1 absent, pursuant to authority vested in the Papago Council by Section 2 (a) and (h) of Article V of the Constitution and 29 By-laws of the Papago Tribe of Arizona ratified by the Tribe on December 12, 1936, 30 31 and approved by the Secretary of the Interior on January 6, 1937, pursuant to 32 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
