## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 66-77 WHEREAS, Larry Garcia has resigned as Chairman and as a member of the Board of Commissioners of the Papago Housing Authority for the purpose of accepting the position of Housing Development Officer. WHEREAS, Article IV of the Ordinance establishing the Papago Housing Authority provides that the Papago Council shall appoint and/or reappoint Board members, and shall name one of the Commissioners, within the Board, as Chairman. NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby accepts the resignation of Larry Garcia. The foregoing Resolution was duly enacted by the Papago Council on the 11th day of August, 1977, at a meeting at which a quorum was present with a vote of 1065.0for; 0 against; 0 not voting; and 1 absent, pursuant to the authority vested in the Council by Section 2 (e) and (f) of Article V of the Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
