

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 69-77

1 WHEREAS, Cameron and Georgie Chavez, enrolled members of Chukut Kuk District and
2 residents of San Miguel Village, are desirous of better housing and
3 have applied for financing through Farmers Home Administration; and

4 WHEREAS, a lot is needed to build a house on; and

5 WHEREAS, the Chavezs appeared before the Chukut Kuk District Council and requested
6 a lot described herein; and

7 WHEREAS, at their meeting of August 20, 1977 the Chukut Kuk District Council
8 did pass a Resolution approving the assignment of said land to the
9 Chavezs for use as a home site; and

10 WHEREAS, it is a Farmers Home Administration requirement that the Tribal Council
11 approve the assignment of said land to Mr. & Mrs. Chavez and also that
12 the Council authorize the Chavezs to encumber the leasehold interest
13 with a Farmers Home Administration approved mortgage.

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does accept, approve,
15 and affirm the Chukut Kuk District Council Resolution.

16 BE IT FURTHER RESOLVED that pursuant to said Resolution it does assign to
17 Cameron & Georgie Chavez that parcel of land lying within the Papago
18 Reservation and described as:

19 That parcel of land in the Papago Indian Reservation, Pima
20 County, Arizona described as follows:

21 Beginning at Sta. 1156409.60 Papago Route #19, Pima County,
22 Arizona

23 Thence N77° 41' 30"W and perpendicular to Papago Route 19 a
24 distance of 156.30 feet to the True Point of Beginning;

25 Thence West a distance of 208.71 feet to a point;

26 Thence North a distance of 208.71 feet to a point;

27 Thence East a distance of 208.71 feet to a point;

28 Thence South a distance of 208.71 feet to the True Point of
29 Beginning.

30 Containing in all 1.0 acres.


31 BE IT FURTHER RESOLVED that said assignment shall be for use as a homesite; and

32 BE IT FURTHER RESOLVED that it does authorize the Chavezs to encumber the lease-
hold interest with a Farmers Home Administration approved mortgage;
and


1 BE IT FURTHER RESOLVED that if the Chavezs should default in payment on said
2 mortgage that the Chukut Kuk District of the Papago Tribe shall have
3 first right to assume said mortgage and/or to assign said mortgage to
4 an eligible Papago resident of the Chukut Kuk District.

5 The foregoing Resolution was duly enacted by the Papago Council on the 13th
6 day of September, 1977, at a meeting at which a quorum was present with a
7 vote of 1065.0 for; 0 against; 0 not voting; and 1 absent,
8 pursuant to authority vested in the Papago Council, Article V, Section 2 (a) (c)
9 & (m) and Article VIII, Section 3 (a) & (b) of the Constitution and By-laws of
10 the Papago Tribe of Arizona ratified by the Tribe on December 12, 1936, and
11 approved by the Secretary of the Interior on January 6, 1934 (48 Stat. 984).
12 Said Resolution is effective as of the date of its approval by the Papago Council
13 and is not subject to review by the Secretary of the Interior.
