

RESOLUTION OF THE PAPAGO COUNCIL


RES. NO. 74-77

1 WHEREAS, the Papago Tribe of Arizona is committed to the economic development  
2 of Papago land and the improvement of economic life for its people; and  
3 WHEREAS, the Papago Council has authorized participation in the United States  
4 Department of Commerce, Economic Development Administration program by  
5 establishing an Overall Economic Development Planning Committee and an  
6 EDA Planning Program; and  
7 WHEREAS, the EDA has authorized a Continuation Grant of \$32,000 to fund the  
8 Papago Economic Development Planning Program for twelve (12) months  
9 from November 1, 1977 through October 31, 1978.


10 NOW, THEREFORE, BE IT RESOLVED that the Papago Council authorizes the application  
11 for these grant continuation funds.

12 The foregoing Resolution was duly enacted by the Papago Council on the 15th  
13 day of September, 1977, at a meeting at which a quorum was present with a  
14 vote of 1011.0 for; 54.0 against; 0 not voting; and 0 absent,  
15 pursuant to authority vested in the Papago Council by Section 2 (f) of Article V  
16 of the Constitution and By-laws of the Papago Tribe of Arizona ratified by the  
17 Tribe on December 12, 1936, and approved by the Secretary of the Interior on  
18 January 6, 1934 (48 Stat. 984). Said Resolution is effective as of the date of  
19 its enactment by the Papago Council and is not subject to review by the Secretary  
20 of Interior.
