16	(a) of Article V of the Constitution and By-laws of the Papago Tribe						
17	as amended, ratified by the Papago Tribe on December 12, 1936, and						
18	approved by the Secretary of the Interior on January 6, 1937, pursuant						
19	to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Reso-						
20	lution is not subject to review by the Secretary of the Interior and						
21	is effective as of the date of its enactment by the Papago Council.
