1	WHEREAS, The President of the United States has proclaimed Indian Self-Determi-						
2	nation as a goal of the government and has made money abailable through						
3	the Indian Health Service for grants to Tribal- Overnments in achieving						
4	self-determination in health areas; and						
5	WHEREAS, such grant funds are now available to Papago for use in health planning,						
6	evaluation, training, federal matching, and to improve and develop the						
7	Tribal health management capability; and						
8	WHEREAS, the Papago Tribal Council in May 1977 did enact Resolution #36-77 and						
9	did identify site planning and preliminary design for the Tribal Health						
10	and Social Complex as a need and did authorize the preliminary phase to						
11	begain; and						
12	WHEREAS, the preliminary phase has been completed and the final phase for the						
13	complete working documents is now the next step.						
14	NOW, THEREFORE, BE IT RESOLVED that the Papago Tribal Council does authorize and						
15	request a P.L. 93-638 implementation grant from the Indian Health Ser-						
16	vice of the Department of Health, Education and Welfare.						
17	BE IT FURTHER RESOLVED that it does authorize the use of said grant funds for						
18	the completion of final working documents in the development of final						
19	phase for construction of the Tribal Health Complex.						
20	BE IT FURTHER RESOLVED that budgets for each of these grant activities shall be						
21	determined by the Chairman and Treasurer in consultation with the Execu-						
22	tive Health Staff and within the total amount of money available from						
23	IHS.						
24	BE IT FURTHER RESOLVED that Mr. Cecil Williams, Chairman; or in his absence,						
25	Mr. Max H. Norris, Vice Chairman; or Mr. Vincent Crawford, Treasurer,						
26	are hereby authorized to negotiate and execute the necessary grant						
27	documents and any supplements, amendments or revisions thereto and to						
28	administer such grant for the duration of the grant.						
29	The foregoing Resolution was duly enacted by the Papago Council on the 7th day						
30	of October, 1977, at a meeting at which a quorum was present with a vote of						
31	1065.0 for; 0 against; 0 not voting; and 0 absent; pursuant to authority						
32	vested in the Papago Council by Section 2 (d) of Article V of the Constitution						
	and By-laws of the Papago Tribe of Arizona, ratified by the Tribe on December						

1 13, 1936, and approved by the Secretary of the Interior on January 6, 1937, pur-2 suant to Section 16 of the Act of June 18, 1934 (48 Stat. 984) Said Resolution 3 is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
