WHEREAS, by Resolution No. 47-77, the Papago Council changed the Tribe's fiscal year from a starting date of July 1 to October 1, in order to be in conformity with that of the federal government, and adopted a carryover budget for the period between the end of the Tribe's 1977 fiscal year and the beginning of its new fiscal year; and

WHEREAS, by Resolution No. 82-77, the Papago Council ratified said Resolution No. 47-77, and adopted an interim 1978 budget for the period of October 1 to December 1, 1977, in order to permit the various departments of the Tribe to complete their budget recommendations in good order; and

WHEREAS, the heads of the various Tribal departments have submitted their recommendations for the 1978 budget to the Papago Council, and the Council has carefully reviewed said recommendations; and

WHEREAS, the Papago Council anticipates receiving sufficient revenues over the fiscal year to cover the Tribal budget.

NOW, THEREFORE, BE IT RESOLVED that the Papago Council adopts the attached budget as the budget of the Papago Tribe at a total figure One Million Eight Hundred Ninety Two Thousand Eight Hundred Eleven Dollars, 892,811.00 ) it being the operating budget for the fiscal year October 1, 1977, through September 30, 1978.

The foregoing Resolution was duly enacted by the Papago Council on the 15th day of December, 1977, at a meeting at which a quorum was present with a vote of 939.5for; 71.5 against; 0 not voting; and 1 absent, pursuant to the authority vested in the Council by Section 3 (a) and (h) of Article V of the Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is subject to review by the Secretary of Interior and is effective as of the date of its enactment by the Papago Council.
