

CITIZEN PARTICIPATION CERTIFICATION FOR THE
HUD-COMMUNITY DEVELOPMENT BLOCK GRANT

RESOLUTION 11-79

1 WHEREAS, The Papago Tribe of Arizona has been invited by the Department of
2 Housing and Urban Development to submit a preapplication for a grant
3 to fund certain eligible Community Development Block Grant Program
4 activities and in connection with such preapplication resolve and make
5 certain assurances;

6 NOW, THEREFORE, BE IT RESOLVED that the Papago Tribe through the Papago HUD-
7 Community Development Block Grant Program has conducted two public
8 hearings for the purpose of hearing the needs of the Papago people
9 under HUD-CDBG Program.

10 These hearings were held January 9 and January 11, 1979 at Sells,
11 Arizona and Santa Rosa Village, Arizona.


12 At these hearings the 11 Districts were also advised to submit a prior-
13 itized list needs which could be funded under this grant. These
14 lists have been submitted to the Papago HUD-CDBG Program

15 The Papago Tribal Council on January 26, 1979, prioritized the district
16 and community requests in the following manner:


- 17 1. Housing Rehabilitation
- 18 2. Bathroom Construction
- 19 3. Community Building & Rehabilitation
of community buildings
- 20 4. Water Lines
- 20 5. Fire Protection
- 20 6. Flood & Drainage

21 The foregoing Resolution was duly enacted by the Papago Council on 26th day
22 of January, 1979, at a meeting at which a quorum was present with a vote of
23 1065 for; 0 against; 0 not voting; and 0 absent, pursuant
24 to the authority vested in the Council by Section 2 (d) of Article V of the
25 Constitution and By-Laws of the Papago Tribe as amended, ratified by the Papago
Tribe on December 12, 1936, and approved by the Secretary of the Interior on
January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984). Said Resolution is not subject to review by the Secretary of Interior
and is effective as of the date of its enactment by the Papago Council.
