

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Appointment of Board of Commissioners,
Papago Housing Authority)

RES. NO. 14-79

1 WHEREAS, Sandra Woolbright and Ambrose Ryes have both resigned as members
2 of the Board of Commissioners of the Papago Housing Authority;

3 WHEREAS, Article IV of the Ordinance establishing the Papago Housing Authority
4 provides that the Papago Council shall appoint and or reappoint Board
5 members;

6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that: Francisco Jose, Jr.
7 and Austin Nunez are hereby appointed to a four year term and Dorothy
8 Lopez is hereby appointed for a 2 year term as a member of the Board
9 of Commissioners of the Papago Housing Authority.

10 The foregoing Resolution was duly enacted by the Papago Council on the 9th day
11 of February 1979, at a meeting at which a quorum was present with a vote of
12 (see attached voting record); pursuant to the authority vested in the Council
13 by Section 2 (e) and (f) of Article V of the Constitution and By-Laws of the
14 Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936,
and approved by the Secretary of the Interior on January 6, 1937, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution
is not subject to review by the Secretary of the Interior and is effective as
of the date of its enactment by the Papago Council.
