

RESOLUTION OF THE PAPAGO COUNCIL
(Gu Achi District)

RES. NO. 15-79

1 WHEREAS, the owners of two patented mining claims located in the
2 Gu Achi District of the Papago Reservation, known as the
3 Hercules and Monarch claims and identified under Mineral
4 Survey 1179, General Land Office No. 26,622 have offered
5 to sell said mining claims to the Papago Tribe for the
6 sum of \$100.00, plus sellers' legal and sales' expenses
7 and property taxes; and

8 WHEREAS, the Gu Achi District Council believes it to be in the
9 best interests of the District and of the Papago Tribe
10 that such offer be accepted, and the patented mining
11 claims be made part of the Papago Reservation; and

12 WHEREAS, the Gu Achi District Council has approved the appro-
13 priation and authorizes the expenditure of sufficient
14 District funds to purchase the two patented mining claims
15 known as the Hercules and Monarch claims with the request
16 that the Papago Council reimburse the Gu Achi District
17 for the cost of acquiring said patented mining claims
18 when the funds become available.

19 NOW, THEREFORE, BE IT RESOLVED that the Papago Council concurs
20 with the Gu Achi District Council that it is in the best
21 interests of the said District and of the Papago Tribe
22 that such offer be accepted for the purchase of the
23 patented mining claims known as the Hercules and Monarch
24 claims for the terms hereinabove set forth.

25 NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Papago
26 Council, and other appropriate officers, agents and
27 attorneys of the Papago Council are hereby authorized to
28 assist the officers of the District Council of Gu Achi
29 District in the purchase and acquisition of said claims
30 for and on behalf of the Papago Tribe, and that said
31 Chairman and other appropriate officers execute any and
32 all documents necessary to complete said purchase.

1 BE IT FURTHER RESOLVED that when the funds become available the
 2 Papago Council will reimburse the Gu Achi District for
 3 the funds appropriated and expended to make said purchase
 4 of the Hercules and Monarch Mining Claims.

5 The foregoing Resolution was duly enacted by the Papago Council
 6 on the 13th day of February, 1979, at a meeting at which a
 7 quorum was present, with a vote of 1065.0 for; 0 against;
 8 0 not voting; and 1 absent, pursuant to the authority
 9 vested in the council by Section 3(a)(h) of Article V of the
 10 Constitution and By-Laws of the Papago Tribe as amended, ratified
 11 by the Papago Tribe on December 12, 1936, and approved by the
 12 Secretary of the Interior on January 6, 1937, pursuant to Section
 13 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution
 14 is effective as of the date of its approval by the Superintendent
 15 of the Papago Agency and is subject to review by the Secretary
 16 of Interior.
