

RESOLUTION OF THE PAPAGO COUNCIL
(Adopting a Third Quarter F.Y. 1979 Interim Budget)

RES. NO. 23-79

WHEREAS, the Papago Council did on October 11, 1978, and on January 5, 1979, respectively by Resolutions No. 53-78 and 1-79, defer adoption of a final 1979 until it could be determined whether the Papago Tribe would receive royalties from the Lakeshore Mine; and

WHEREAS, the Papago Tribe has entered into a new mining lease and a business lease with Noranda Exploration Company effective April 1, 1979, making certain payments and royalty commitments to the Tribe relative to the Lakeshore Mine; and

WHEREAS, the Papago Council has today appointed a Budget Committee to make budget recommendations to the Papago Council for the remainder of F.Y. 1979; and

WHEREAS, the Papago Council believes that it is in the best interest of the Papago Tribe to further defer the adoption of the final F.Y. 1979 budget until the Budget Committee has had time to review budget requests and to make recommendations to the Papago Council.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby adopt a third quarter F.Y. 1979 interim budget for the period of April 1, 1979, to July 1, 1979, consisting of (a) one-quarter (1/4) of the F.Y. 1978 budget, not including costs for capital equipment, plus (b) any unused portions of such budget for capital equipment.

The foregoing Resolution was duly enacted by the Papago Council on 6 day of April, 1979, at a meeting at which a quorum was present with a vote of 922.5 for; 0 against; 142.5 not voting; and 2 absent, pursuant to authority vested in the Council by Section 3 (a) and (h) of Article V of the Constitution and By-Laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.


