

RESOLUTION OF THE PAPAGO TRIBE
(Orville Rorabaugh)

RES. NO. 32-79

1 WHEREAS, Orville Rorabaugh owns a patented mining claim in Sif Oidak District
2 near Jackrabbit Village, and

3 WHEREAS, Mr. Rorabaugh has requested permission from the Sif Oidak District
4 to allow him a right-of-way to his residence for telephone service,
5 and

6 WHEREAS, Mr. Rorabaugh has informed the Sif Oidak District that they are
7 welcome to use his telephone in times of an emergency, and


8 WHEREAS, the people in Sif Oidak District and Mr. Rorabaugh are in good rapport
9 with each other and want to continue in this manner, and

10 WHEREAS, the Sif Oidak District Council granted permission to Mr. Rorabaugh for
11 a right-of-way to his residence for telephone service as this will
12 benefit both Mr. Rorabaugh and the people of the District.

13 NOW, THEREFORE, BE IT RESOLVED that the Papago Tribal Council hereby approve
14 Sif Oidak District Council's Resolution No. 78-2, passed on
15 September 22, 1978.

17 The foregoing Resolution was duly enacted by the Papago Council on the 20th.
18 day of April, 1979, at a meeting at which a quorum was present, with a vote of
19 798 for; 175 against; 92 not voting; and 1 absent, pursuant to
20 the authority vested in the council by Section II. (a) and (h) of Article V of
21 the Constitution and By-Laws of the Papago Tribe as amended, ratified by the
Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior
on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984). Said Resolution is not subject to review by the Secretary of Interior
and is effective as of the date of its enactment by the Papago Council.
