

RESOLUTION OF THE PAPAGO COUNCIL
(Authorizing Certification of Candi-
dates for Chairman and Vice Chairman)

RES. NO. 35-79

WHEREAS, a primary election was held on April 28, 1979, in accordance with the Uniform Election Ordinance for the purpose of selecting two candidates to run in the general election scheduled on May 26, 1979, for the offices of Chairman and Vice-Chairman of the Papago Council; and

WHEREAS, the Papago Election Board did on April 28, 1979, issue its Certificate of Election Results, which Certificate was posted as required in the Uniform Election Ordinance and certifies that the following two candidates for the offices of the Chairman and Vice-Chairman of the Papago Council received the highest number of votes for their respective offices, to-wit:

1) for Chairman Cipriano J. Manuel

Max H. Norris

2) for Vice-Chairman Enos J. Francisco

Andrew Lorentine

NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby authorize and direct the Chairman and Secretary of the Papago Council to issue a Certificate of Election on behalf of the Papago Council to the following persons, to-wit:

1) As candidates for the office of the Chairman of the Papago Council, subject to the general election:

Cipriano J. Manuel

Max H. Norris

2) As candidates for the office of Vice-Chairman of the Papago Council, subject to the general election:

Enos J. Francisco

2 the 4th day of May, 1979, at a meeting at which a quorum was
3 present with a vote of 1022 for; 0 against: 43 not
4 voting; and 0 absent, pursuant to the authority vested in
5 the Papago Council contained in Article III and Section 1 (f)
6 and (m) of Article V of the Constitution and By-Laws of the Papago
7 Tribe as amended, ratified by the Papago Tribe on December 12,
8 1936, and approved by the Secretary of the Interior on January 6,
9 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
10 984). Said Resolution is not subject to review by the Secretary
11 of Interior and is effective as of the date of its enactment by
12 the Papago Council.
