

RESOLUTION OF THE PAPAGO COUNCIL
(Authorizing Endorsement of EDA)
(Grant to San Xavier Development)
Authority)

RES. NO. 48-79

1 WHEREAS, the Papago Council did on July 22, 1977, by Resolution
2 No. 59-77, authorize the acceptance of an EDA offer of
3 Grant (EDA Project No. 07-01-01928) for the engineering
4 and construction of the proposed Papago Tribe Indian
5 Business Opportunity Building to be located on leased
6 land within the San Xavier Industrial Park; and

7 WHEREAS, such grant is to foster and promote Indian businesses and
8 employment, and is conditioned upon securing Indian
9 industrial tenants; and

10 WHEREAS, since acceptance of the grant, the Papago Council has by
11 Ordinance created the San Xavier Development Authority,
12 a non-profit public body formed to foster and promote
13 the development of business and employment opportunities
14 in the San Xavier District of the Papago Reservation; and

15 WHEREAS, it is to the benefit of the Papago Tribe that the Indian
16 Business Opportunity Building be owed, operated and ad-
17 ministered by the San Xavier Development Authority under
18 its Tribal charter.

19 NOW THEREFORE, BE IT RESOLVED by the Papago Council that it does
20 hereby approve the endorsement by the Papago Tribe of the
21 offer of Grant of the Economic Development Authority of
22 the U.S. Department of Commerce (Project No. 07-01-01928)
23 to the San Xavier Development Authority, and does hereby
24 authorize and direct the Chairman and other appropriate
25 officers of the Papago Council, on behalf of the Papago
26 Tribe, to execute and file any and all appropriate instru-
27 ments with the U.S. Department of Commerce to effectuate
28 the purposes of this Resolution.

29 BE IT FURTHER RESOLVED that upon endorsement of such EDA Offer of
30 Grant to the San Xavier Development Authority, the lease
31 dated July 22, 1977, between the Papago Tribe and Papago-
32 Tucson Development Cooperation to Lots 12 and 13 of the

1 San Xavier Industrial Park be terminated and voided.

2 The foregoing Resolution was duly enacted by the Papago Council
3 on the 5th. day of June, 1979, at a meeting at which a quorum was
4 present with a vote of 312.5 for; 0 against; 542.5 not
5 voting; and 2 absent, pursuant to the authority vested in
6 the Council by Section 2 (a), (e), (f) and (h) of Article V of the
7 Constitution and By-Laws of the Papago Tribe as amended, ratified
8 by the Secretary of the Interior on January 6, 1937, pursuant to
9 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
10 Resolution is not subject to review by the Secretary of Interior
11 and is effective as of the date of its enactment by the Papago
12 Council.
