

RESOLUTION OF THE TRIBAL COUNCIL

RESOLUTION NO. 61-79

1 WHEREAS, the Papago Tribe has retained the law firm of Strickland and

2 Altaffer under a General Counsel Contract; and

3 WHEREAS, said General Counsel Contract expires in September, 1979; and

4 WHEREAS, it is the desire of the Papago Tribe that an evaluation of the Legal
5 Counsel be performed before renewal of contract.

6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that evaluation of the
7 Legal Counsel be executed.

8 The foregoing Resolution was duly enacted by the Papago Council on the 10th.
9 day of July 1979, at a meeting at which a quorum was present with a vote of
10 914.5 for; 0 against; 0 not voting; and 1 absent; pursuant to the
11 authority vested in the council by Section II (b) of Article V of the
12 Constitution and By-Laws of the Papago Tribe as amended, ratified by the Papago
13 Tribe on December 12, 1936, and approval by the Secretary of the Interior on
14 January 6, 1937, pursuant to Section 16 of the Act of June 18 1934. (48 Stat.
15 984). Said Resolution is not subject to review by the Secretary of Interior
16 and is effective as of the date of its enactment by the Papago Council.
