NOW, THEREFORE, BE IT RESOLVED by the Papago Council that evaluation of the Legal Counsel be executed. The foregoing Resolution was duly enacted by the Papago Council on the 10th. day of July 1979, at a meeting at which a quorum was present with a vote of 914.5 for; 0 against; 0 not voting; and 1 absent; pursuant to the authority vested in the council by Section II (b) of Article V of the Constitution and By-Laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approval by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18 1934.
