

APPOINTMENT OF CHIEF JUDGE OF THE PAPAGO
TRIBAL COURT BE DEFERRED TO February 2, 1979

RESO. NO. 06-79

1 WHEREAS, a motion was made from the floor and seconded that consideration
2 of the appointment of a Chief Judge of the Papago Tribal Court
3 be deferred until February 2, 1979, so that members of the Papago
4 Council could secure the recommendations from their respective
5 Districts; and

6 WHEREAS, upon motion duly made and seconded, the foregoing motion was put
7 before the Papago Council and was defeated.

8 The foregoing motion was defeated by the Papago Council on 10th day of
January, 1979, at a meeting at which a quorum was present with a vote of
9 342.5 for; 364.5 against; 358 not voting; and 2 absent; pursuant
10 to authority vested in the Papago Council by Section 2 (a) of Article V of the
Constitution and By-Laws of the Papago Tribe, as amended, ratified by the
Tribe on December 12, 1936, and approved by the Secretary of the Interior on
11 January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984). Said Resolution is not subject to review by the Secretary of the
12 Interior.
