

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Return of Calves from Black Angus
Heifer Project)

RESOLUTION NO. 77-79

1 WHEREAS, by Resolution No. 16-73 the Papago Council did on April 6,
2 1973, authorize the loan of 106 head of Black Angus cows
3 constituting the Heifer Project to members of those eleven
4 Districts of the Papago Reservation designated by their
5 respective District Councils; and

6 WHEREAS, such loans were conditioned upon the delivery back to the
7 Tribal Herd of the first yearling calf offspring of such
8 loaned cows; and

9 WHEREAS, Resolution No. 16-73 placed upon the District Councils
10 the responsibility to see that such yearlings be returned
11 to the Tribal Herd; and

12 WHEREAS, very few of such yearlings were in fact returned to the
13 Tribal Herd and the Papago Tribe is entitled to the return
14 of either the loaned animals or of their offspring.

15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does
16 hereby authorize and direct the Tribal Herd Manager to
17 take possession from the persons who received loans of
18 Black Angus cows of such cows or one of their offspring,
19 and that he is authorized to add them to the Tribal Herd
20 and/or dispose of same by sale as good husbandry and
21 economic conditions suggest.

22 The foregoing Resolution was duly enacted by the Papago Council on
23 the 7th day of September 1979, at a meeting at which a quorum
24 was present with a vote of 854 for; 0 against; 111 not voting
25 ; and 1 absent, pursuant to the authority vested in the Council by
26 Section 2 (e) (f) of Article V of the Constitution and By-Laws of
27 the Papago Tribe as amended, ratified by the Papago Tribe on Decem-
ber 12, 1936, and approved by the Secretary of the Interior on
January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984). Said Resolution is not subject to review by the
Secretary of Interior and is effective as of the date of its enact-
ment by the Papago Council.
