

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Authorizing First National Bank Loan  
for TWEPE Programs)

Resolution No. 84-79

1 WHEREAS, The Papago Tribe operates a Tribal Works Experience  
2 Program (TWEPE) on the Papago Reservation under P.L.  
3 93-638; and

4 WHEREAS, the Papago Tribe has been advised by the Area Office  
5 of the B.I.A. that though Congress has not completed  
6 FY 1980 appropriations to fund existing B.I.A. programs  
7 funds would become available to the B.I.A. to contract  
8 with the Papago Tribe for continued TWEPE operations on  
9 the Papago Reservation; and

10 WHEREAS, the Papago Council feels obligated to the participants  
11 in the TWEPE Program to continue the Papago TWEPE Program  
12 beyond October 1, 1979, and will have to borrow funds in  
13 order to continue the program into FY 1980.

14 NOW, THEREFORE, BE IT RESOLVED that in order to fund continued  
15 operation of the Papago TWEPE Program the Papago Council  
16 does hereby authorize and approve the borrowing of a  
17 sum not to exceed \$35,000.00 from the First National  
18 Bank of Arizona ("Bank"), pursuant to the terms and  
19 conditions of an existing Loan Agreement with the Bank  
20 dated March 15, 1978, or such other terms as the Chair-  
21 man of the Papago Council may negotiate.

22 BE IT FURTHER RESOLVED, that Max H. Norris, the Chairman, or Enos  
23 J. Francisco, Jr., Vice-Chairman, and Mary Jane Narcho,  
24 Secretary of the Papago Tribal Council, are hereby  
25 authorized to sign and execute a promissory note, or  
26 notes, and such other agreement or documents as may be  
27 necessary to obtain such loan.

28 The foregoing Resolution was duly enacted by the Papago Council on  
29 the 12th. day of October, 1979, at a meeting at which a quorum  
30 was present with a vote of 825 for; 0 against; 140 not  
31 voting; and 1 absent, pursuant to the authority vested in the  
32 Council by Section 2 (f) and (h) and Section 3 (h) of Article V of  
the Constitution and By-Laws of the Papago Tribe as amended,  
ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to  
Section 16 of the Act of June 18, 1934, (48 Stat. 984). Said  
Resolution is not subject to review by the Secretary of Interior  
and is effective as of the date of its enactment by the Papago  
Council.
