

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Authorizing Valley National Bank)  
( loan for CETA Programs )

RES. NO. 85-79

1 WHEREAS, the Papago Tribe, as a prime sponsor, operates the Papago-CETA  
2 Programs on the Papago Reservation under the Comprehensive  
3 Employment and Training Act of 1973, as amended; and

4 WHEREAS, the Papago Tribe has been advised by the U. S. Department of  
5 Labor that, though Congress has not completed FY 1980 appro-  
6 priations to fund existing CETA Programs authorized under the  
7 Comprehensive Employment and Training Act, Reauthorization  
8 (Act of October 27, 1978), funds would become available to the  
9 Department to meet its contract obligations with the Papago  
10 Tribe; and


11 WHEREAS, the Papago Tribe is by contract obligated to continue the Papago  
12 CETA Programs, and will have to borrow funds in order to continue  
13 these programs into FY 1980,

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
15 authorize and approve the securing of a loan up to the amount  
16 of \$200,000.00 from the Valley National Bank of Arizona, Down-  
17 town Office, Tucson, Arizona, to fund the Papago-CETA Programs; and

18 BE IT FURTHER RESOLVED, that Max H. Norris, the Chairman, or Enos J.  
19 Francisco, Jr., Vice Chairman, and Mary Jane Narcho, Secretary of  
20 the Papago Tribal Council, are hereby authorized to sign and  
21 execute a promissory note, or notes, and such other documents as  
22 may be necessary to obtain such loan.

23 The foregoing Resolution was duly enacted by the Papago Council on the 12th  
24 day of October, 1979, at a meeting at which a quorum was present with a  
25 vote of 927 for; 0 against; 38 not voting; and 1 absent,  
26 pursuant to the authority vested in the Council by Section 2 (f) and (h)  
27 and Section 3 (h) of Article V of the Constitution and By-laws of the Papago  
28 Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and  
29 approved by the Secretary of the Interior on January 6, 1937, pursuant to  
30 Section 16 of the Act of June 18, 1934, (48 Stat. 984). Said Resolution is  
31 not subject to review by the Secretary of Interior and is effective as of  
32 the date of its enactment by the Papago Council.
