1 WHEREAS, the San Xavier District Council, by resolution dated October 11, 1979,
2 considered and approved a District budget for the period commencing
3 October 1, 1979 and ending September 30, 1980, a copy of said
4 resolution is attached hereto and made a part hereof, and


5 WHEREAS, the Papago Council has reviewed said budget and the Districts income
6 for this twelve month period and

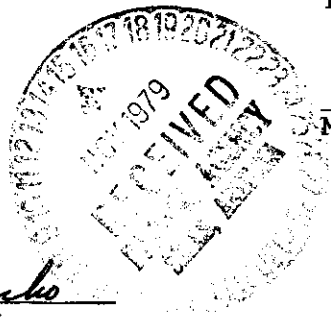
7 WHEREAS, the Papago Council has determined that San Xavier District has
8 sufficient funds to cover its budget and that the approval of said
9 budget would be in the best interest of the people living in said
10 District.

11 NOW THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve the
12 San Xavier District budget as set forth in the October 11, 1979
13 District Resolution attached hereto and made a part hereof.


14 The foregoing Resolution was duly enacted by the Papago Council on the 7th
15 day of November, 1979, at a meeting at which a quorum was present with a vote
16 of 965 for; 0 against; 0 not voting; and 1 absent, pursuant to
17 authority vested in the Papago Council by Article V, Section 3 (a) (h) of the
18 Constitution and By-Laws of the Papago Tribe of Arizona, ratified by the Tribe
19 on December 12, 1936, and approved by the Secretary of the Interior on January
20 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat 984).
21 Said Resolution is effective as of the date of its approval by the Superinten-
22 dent of the Papago Agency, and is subject to review by the Secretary of the
23 Interior.
