

1 WHEREAS, Section 2 of Chapter I of the Law and Order Code provides for  
2 the appointment of Judges of the Papago Tribal Courts by the  
3 Commissioner of Indian Affairs, subject to confirmation by a  
4 majority vote of the Papago Council; and

5 WHEREAS, such appointment is for a maximum term of two years; and


6 WHEREAS, Sarah Corella was, in 1977, appointed as Judge of the Papago  
7 Tribal Court, for a two year term, which expired on January  
8 7, 1979; and

9 WHEREAS, it is the recommendation of the Papago Council that Hilda  
10 Manuel be appointed as Judge for a two year term.

11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does  
12 hereby recommend to the Commissioner of Indian Affairs the  
13 appointment of Hilda Manuel, and does confirm such appoint-  
14 ment as Chief Judge of the Papago Tribal Court.

15 The foregoing resolution was duly enacted by the Papago Council on the 10th  
16 day of January, 1979, at a meeting at which a quorum was present (see attached  
17 voting record), pursuant to the authority vested in the Papago Council by  
18 Section 2 (e) and (f) of Article V of the Constitution and By-Laws of the  
19 Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936,  
and approved by the Secretary of the Interior on January 6, 1937, pursuant to  
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
not subject to review by the Secretary of Interior and is effective as of the  
date of its enactment by the Papago Council.
