

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RESO. NO. 89-79

1 WHEREAS, the Papago Tribe of Arizona is presently operating an Alcoholism  
2 Prevention and Education Program under P.L. 93-638 cost reimburse-  
3 ment contract with the Indian Health Services (I.H.S.) Contract  
4 No. 249-76-0010

5 WHEREAS, the Papago Tribe recognizes the necessity for, and contribution of  
6 self-evaluation of efficient and effective health program planning  
7 and implementation


8 NOW THEREFORE, BE IT RESOLVED by the Papago Council that it does authorize  
9 and request that the Indian Health Services enter into a P.L. 93-638  
10 cost reimbursement contract with the Papago Tribe to perform such a  
11 self-evaluation of the Papago Alcoholism Program

12 BE IT FURTHER RESOLVED that Mr. Max H. Norris, Chairman; or in his absence,  
13 Mr. Enos J. Francisco, Jr., Vice Chairman; or the Treasurer is hereby  
14 authorized to negotiate and execute this contract and any amendments  
15 there for the duration of the contract

16 BE IT FURTHER RESOLVED that the duration of this contract shall expire twelve  
17 (12) months after it is initiated, unless extended by mutual agree-  
18 ment of both parties.


19 The foregoing Resolution was duly enacted by the Papago Council on the 8th  
20 day of November, 1979, at a meeting at which a quorum was present with a vote  
21 of 927 for; 38 against; 0 not voting; 1 absent, pursuant to authority  
22 vested in the Papago Council by Article V, Section 2 (a) (h) of the Constitution  
23 and By-Laws of the Papago Tribe of Arizona ratified by the Tribe on December 12,  
1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
not subject to review by the Secretary of Interior and is effective as of the  
date of its enactment by the Papago Council.
