WHEREAS, it is to the benefit of the Papago Tribe to contract to provide ground maintenance, janitorial services, and disposal services for the San Simon School, and ground maintenance and janitorial services for the Santa Rosa Boarding School, and

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the Chairman or other designated officers of the Papago Council are hereby authorized to negotiate and sign, on behalf of the Papago Tribe, a contract with the Bureau of Indian Affairs to provide ground maintenance, janitorial services, and disposal services for the San Simon School, and ground maintenance and janitorial services for the Santa Rosa Boarding School.

The foregoing Resolution was duly enacted by the Papago Council on the 7th day of December, 1979, at a meeting at which a quorum was present with a vote of 965 for; 0 against; 0 not voting; and 0 absent, pursuant to authority vested in the Papago Council by Section 2 (a) and (d) of Article V of the Constitution and By-Laws of the Papago Tribe of Arizona ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (48 Stat. 984) pursuant to Section 16 of the Act of June 19, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is not subject to review by the Secretary of the Interior.
