

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Buy Indian Contract - San Simon/Santa  
Rosa Boarding School, Janitorial &  
Maintenance Services)

RESOLUTION NO. 95-79

2 WHEREAS, it is to the benefit of the Papago Tribe to contract to  
3 provide ground maintenance, janitorial services, and  
4 disposal services for the San Simon School, and ground  
5 maintenance and janitorial services for the Santa Rosa  
6 Boarding School, and

7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the  
8 Chairman or other designated officers of the Papago  
9 Council are hereby authorized to negotiate and sign, on  
10 behalf of the Papago Tribe, a contract with the Bureau  
11 of Indian Affairs to provide ground maintenance,  
12 janitorial services, and disposal services for the San  
13 Simon School, and ground maintenance and janitorial  
14 services for the Santa Rosa Boarding School.

16 The foregoing Resolution was duly enacted by the Papago Council  
17 on the 7th day of December, 1979, at a meeting at which a quorum  
18 was present with a vote of 965 for; 0 against; 0 not voting;  
19 and 0 absent, pursuant to authority vested in the Papago Council  
20 by Section 2 (a) and (d) of Article V of the Constitution and  
21 By-Laws of the Papago Tribe of Arizona ratified by the Tribe on  
22 December 12, 1936, and approved by the Secretary of the Interior  
23 on January 6, 1937, (48 Stat. 984) pursuant to Section 16 of the  
24 Act of June 19, 1934. Said Resolution is effective as of the  
25 date of its approval by the Superintendent of the Papago Agency  
26 and is not subject to review by the Secretary of the Interior.
