


RESOLUTION OF THE PAPAGO COUNCIL
Contract for Detention Services

Res. No. 97-79

1 WHEREAS, the Papago Tribe is in need of personnel and services in
2 the area of detention services for the Papago Jail
3 WHEREAS, P.L. 93-638, the Indian Self-Determination and Education
4 Assistance Act provides that Indian Tribes can contract
5 for services provided by the Bureau of Indian Affairs
6 WHEREAS, the Papago Council does desire to contract for the pro-
7 vision of detention services for the period of January 1,
8 1980 through September 30, 1980, and
9 WHEREAS, the approval of this contract will not displace any
10 Bureau of Indian Affairs personnel
11 NOW THEREFORE BE IT RESOLVED by the Papago Council that it does
12 authorize and request the Bureau of Indian Affairs to
13 contract with the Papago Tribe under P.L. 93-638 regula-
14 tions and procedures for the provision of detention
15 services in accordance with the attached program, staff-
16 ing and budget request.
17 BE IT FURTHER RESOLVED THAT Mr. Max H. Norris, Chairman, or in
18 his absence, Mr. Enos J. Francisco, Jr., Vice-Chairman,
19 are hereby authorized to negotiate and execute the
20 contract and any amendments thereto for the duration of
21 the contract.

22 The foregoing Resolution was duly enacted by the Papago Council
23 on the 7th day of December, 1979, at a meeting at which a quorum
24 was present with a vote of 965 for, 0 against, 0 not voting and
25 0 absent, pursuant to authority vested in the Papago Council by
26 Section 2 (a) and (d) of Article V of the Constitution and By-
27 Laws of the Papago Tribe of Arizona ratified by the Tribe on
28 December 12, 1936, and approved by the Secretary of the Interior
29 on January 6, 1937, (48 Stat. 984) pursuant to Section 16 of the
30 Act of June 19, 1934. Said Resolution is effective as of the
31 date of its approval by the Superintendent of the Papago Agency
32 and is not subject to review by the Secretary of the Interior.


