

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Cattle Buyer's Permit Cholla Cattle
Co., Mel Roether/Fred Lueck, Jr.)

RESOLUTION No. 98-79

1 WHEREAS, Mr. Mel Roether, doing business as Cholla Cattle Company,
2 a partnership consisting of Mel Roether and Fred Lueck,
3 Jr., has made applications for a cattle buyer's permit;
4 and

5 WHEREAS, Mr. Roether has assured the Papago Council that he plans
6 to establish and maintain an office in Sells, and that he
7 has proceeded and will maintain a \$5,000 bond from the
8 Merchants Mutual Bonding Company; and

9 WHEREAS, Mr. Roether and his family have a long established cattle
10 buying history on the Papago Reservation.

11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does
12 hereby approve the granting of a cattle buyer's permit to
13 Mr. Mel Roether id.b.a. Cholla Cattle Company, upon his
14 foregoing assurances.

15 BE IT FURTHER RESOLVED that the Chairman or Vice Chairman of the
16 Papago Council is hereby authorized and directed to
17 execute and issue such permit on behalf of the Papago
18 Tribe pursuant to Ordinances No. 35 and 36.

19 The foregoing Resolution was duly enacted by the Papago Council on
20 the 10th day of December, 1979, at a meeting at which a quorum
21 was present with a vote of 688 for; 38 against; 210 not vot-
22 ing; and 3 absent; pursuant to the authority vested in the
23 Council by Section 2 (a) and 3 (c) (e) of Article V of the
24 Constitution and By-Laws of the Papago Tribe as amended, ratified
25 by the Papago Tribe on December 12, 1936, and approved by the
26 Secretary of the Interior on January 6, 1937, pursuant to Section
27 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
28 effective as of the date of its approval by the Superintendent of
29 the Papago Agency and is subject to review by the Secretary of
30 Interior.
