

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Appointing Secretary of the Papago Council)

RES. NO. 02-81

1 WHEREAS, the By-laws of the Papago Tribe provide for the position of a
2 Secretary of the Papago Council to "keep the minutes of all
3 regular and special meetings, conduct all tribal correspondence
4 and keep an accurate record of all business transacted;" and


5 WHEREAS, there exists a vacancy in the position of Secretary of the
6 Papago Council and such position has been advertised in accordance
7 with the provisions of the Personnel Policies of the Papago
8 Tribe; and

9 WHEREAS, Rose M. Johnson has applied for the position and has been interviewed
10 and found by the Papago Council to have the necessary qualifications
11 for the position.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
13 appoint Rose M. Johnson as Secretary of the Papago Council to
14 serve until replaced at the pleasure of the Papago Council.

15 The foregoing Resolution was duly enacted by the Papago Council on the 7th
16 day of January, 1981, at a meeting at which a quorum was present with a vote
17 of 526. for; 439. against; 0 not voting; and 1 absent,
18 pursuant to the authority vested in the Papago Council by Section 2 (e) and (f)
19 of Article V of the Constitution and By-laws of the Papago Tribe of Arizona
20 as amended, ratified by the Papago Tribe on December 12, 1936, and approved
21 by the Secretary of the Interior on January 6, 1937, pursuant to Section 16
22 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject
23 to review by the Secretary of the Interior and is effective as of the date
24 of its enactment by the Papago Council.
