

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Appointing Associate Judge of)
(the Papago Tribal Courts)

RES. NO. 03-81

1 WHEREAS, a position as Associate Judge of the Papago Tribal Courts is presently
2 vacant; and

3 WHEREAS, Section 2 of Chapter 1 of the Law and Order Code of the Papago Tribe
4 provides that Judges "shall be appointed by the Commissioner of
5 Indian Affairs, subject to confirmation by a majority vote of the
6 Papago Council;" and

7 WHEREAS, the Law and Order Committee has recommended the appointment of
8 Mabel P. Antone for the position of Associate Judge of the Papago
9 Tribal Courts; and

10 WHEREAS, Mabel P. Antone meets all of the qualifications for such position.

11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
12 designate and confirm the appointment of Mabel P. Antone as
13 Associate Judge of the Papago Tribal Courts for a term of two
14 years from date of appointment, and requests that the Commissioner
15 of Indian Affairs appoint its designee to such position.

16 The foregoing Resolution was duly enacted by the Papago Council on the 7th
17 day of January, 1981, at a meeting at which a quorum was present with a vote
18 of 965. for; 0 against; 0 not voting; and 1 absent,
19 pursuant to the authority vested in the Papago Council by Section 2 (e) and
20 (f) and Section 3 (b) of Article V of the Constitution and By-laws of the
21 Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December
22 12, 1936, and approved by the Secretary of the Interior on January 5, 1937,
23 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
24 Resolution is effective as of the date of its approval by the Superintendent
25 of the Papago Agency and is subject to review by the Secretary of the Interior.
