 20 Papago Tribe under Section 1 (a) or (b) of Article II of the  
 21 Papago Constitution and By-laws, as amended, and their  
 22 applications are approved, as herein above indicated.

23 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of  
 24 the Papago Tribe reduce this final determination in writing  
 25 regarding each of the foregoing applications for enrollment in  
 26 accordance with Section 3 (c) of Article III of the Papago Tribe  
 27 Enrollment Ordinance; give notice of this Council's determination;  
 28 and place the names of each applicant upon the Tribal Membership  
 29 Roll in accordance with Article V of the Papago Tribe Enrollment  
 30 Ordinance.

31 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
 32 day of January, 1981, at a meeting at which a quorum was present with a vote  
 of 965 for; 0 against; 0 not voting; and 3 absent,


