

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Protesting Bureau of the Census)
(Preliminary Population Count)

RES. NO. 07-81

1 WHEREAS, the Bureau of the Census has advised the Papago Tribe that its
2 field operations on the Papago Reservation covering the 1980
3 Decennial Census had been completed and that its preliminary
4 population count for the Papago Reservation is 7951; and
5 WHEREAS, the official records of the Papago Tribe's Enrollment Office
6 show that in excess of 11,500 applications have been filed by
7 persons claiming membership in the Papago Tribe and residing
8 within the eleven Districts of the Papago Reservation; and
9 WHEREAS, the Papago Council has been advised by the Enrollment Office
10 that there are a substantial number of persons residing on the
11 Papago Reservation who have not yet filed their membership
12 applications and that consequently the undercount contained
13 in the preliminary population count of the Bureau of the Census
14 will substantially exceed 3,549 once all membership applications
15 of persons residing on the Papago Reservation and qualifying
16 for membership in the Papago Tribe have been filed; and
17 WHEREAS, the Papago Council is concerned about the serious discrepancy
18 between the preliminary population count of the Bureau of the
19 Census and the actual count of persons residing on the Papago
20 Reservation (not including persons who do not claim membership
21 in the Papago Tribe) made by the Tribe's Enrollment Office.
22 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
23 protest the 1980 Decennial Census preliminary population count
24 of 7951 made by the Bureau of Census and does hereby urgently
25 request the Director of the Bureau of the Census to completely
26 review the Bureau's field operation records and to adjust its
27 population count to correctly reflect the actual census of
28 persons, including non-members of the Papago Tribe, who
29 reside on the Papago Reservation prior to release of the
30 Bureau's final counts.
31 BE IT FURTHER RESOLVED by the Papago Council that the Chairman, Vice
32 Chairman, attorneys and other appropriate officers of the


Papago Tribe are hereby authorized and directed to take such action as they deem necessary and proper to effectuate the purposes of this Resolution.

The foregoing Resolution was duly enacted by the Papago Council on the 8th day of January, 1981, at a meeting at which a quorum was present with a vote of 876.5 for; 0 against; 0 not voting; and 3 absent, pursuant to the authority vested in the Papago Council by Section 2 (a), (e), (f) and (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 5, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
