

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Requesting Secretary to Prepare Plan for)
(Use and Distribution of Judgment Funds)

RES. NO. 08-81

1 WHEREAS, the Secretary of Interior has the responsibility to prepare a plan
2 for the use and distribution of the judgment funds awarded the
3 Papago Tribe pursuant to the Act of September 30, 1976, P. L.
4 94-438, 90 Stat. 1416; and

5 WHEREAS, individual members and entities of the Papago Tribe, including a
6 Committee of District Chairmen, various Districts of the Papago
7 Reservation and a joint B.I.A.-Tribe Committee have prepared
8 various plans for the use and distribution of these judgment
9 funds; and

10 WHEREAS, such proposed plans, and any other material information available
11 to the Secretary should be sufficient for the Secretary to proceed
12 with his statutory duties of preparing his plan and hold public
13 hearings of record thereon.

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that all resolutions
15 and communications submitted to the Papago Council and Tribe from
16 all tribal members and legal entities entitled to receive judgment
17 funds, including plans proposed by a Committee of District Chairmen
18 submitted to the Papago Council in January, 1980, plans proposed
19 by the various Districts, and the plan dated February 2, 1981 and
20 submitted to the Papago Council on this date by the joint BIA-Tribe
21 Committee, be submitted to the Secretary of Interior for considera-
22 tion, with the request that the Secretary prepare a plan for the
23 use and distribution of the Tribe's judgment funds pursuant to
24 25 U.S.C. 1403 (a) and hold public hearings of record thereon
25 pursuant to 25 U.S.C. 1403 (b).

26 BE IT FURTHER RESOLVED by the Papago Council that the Chairman and other
27 appropriate officers of the Papago Tribe, and the officers of the
28 Papago B.I.A. Agency submit all available resolutions and communica-
29 tions submitted to the Papago Council, the Tribe and the BIA Agency
30 from all members and entities entitled to judgment funds to the
31 Secretary in order to enable the Secretary to prepare such plan.

32 The foregoing Resolution was duly enacted by the Papago Council on the 3rd

1 day of February, 1981, at a meeting at which a quorum was present with a
2 vote of 965. for; 0 against; 0 not voting; and 2 absent,
3 pursuant to the authority vested in the Papago Council by Section 2 (a), (c),
4 (d) and (f) of Article V of the Constitution and By-laws of the Papago Tribe
5 of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
6 approved by the Secretary of the Interior on January 6, 1937, pursuant to
7 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
8 not subject to review by the Secretary of the Interior and is effective as
9 of the date of its enactment by the Papago Council.
