(Requesting Secretary to Prepare Plan for) (Use and Distribution of Judgment Funds )

1	WHEREAS,	the Secretary of Interior has the responsibility to prepare a plan
2		for the use and distribution of the judgment funds awarded the
3		Papago Tribe pursuant to the Act of September 30, 1976, P. L.
4		94-438, 90 Stat. 1416; and
5	WHEREAS,	individual members and entities of the Papago Tribe, including a
6		Committee of District Chairmen, various Districts of the Papago

Committee of District Chairmen, various Districts of the Papago
Reservation and a joint B.I.A.—Tribe Committee have prepared
various plans for the use and distribution of these judgment
funds; and

WHEREAS, such proposed plans, and any other material information available to the Secretary should be sufficient for the Secretary to proceed with his statutory duties of preparing his plan and hold public hearings of record thereon.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that all resolutions and communications submitted to the Papago Council and Tribe from all tribal members and legal entities entitled to receive judgment funds, including plans proposed by a Committee of District Chairmen submitted to the Papago Council in January, 1980, plans proposed by the various Districts, and the plan dated February 2, 1981 and submitted to the Papago Council on this date by the joint BIA-Tribe Committee, be submitted to the Secretary of Interior for consideration, with the request that the Secretary prepare a plan for the use and distribution of the Tribe's judgment funds pursuant to 25 U.S.C. 1403 (a) and hold public hearings of record thereon pursuant to 25 U.S.C. 1403 (b).

BE IT FURTHER RESOLVED by the Papago Council that the Chairman and other appropriate officers of the Papago Tribe, and the officers of the Papago B.I.A. Agency submit all available resolutions and communications submitted to the Papago Council, the Tribe and the BIA Agency from all members and entities entitled to judgment funds to the Secretary in order to enable the Secretary to prepare such plan.
