9	the Papago Runner, in the amount of \$2,169,000.00.							
10	The foregoing Resolution was duly enacted by the Papago Council on the 24th day of August, 1981, at a meeting at which a quorum was present with a vote of 381.5 for; 766.5 against; 0 not voting; and 0 absent, pursuant to the authority vested in the Papago Council by Section 2 (e) and (f) of

12	Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by
