(ENROLLMENT)

6 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above  
7 named applicants are eligible for enrollment as members of the  
8 Papago Tribe under Section 1 (a) or (b) of Article II of the  
9 Papago Constitution and By-laws, as amended, and their applications  
10 are approved, as herein above indicated.

11 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of  
12 the Papago Tribe reduce this final determination in writing regarding  
13 each of the foregoing applications for enrollment in accordance  
14 with Section 3 (c) of Article III of the Papago Tribe Enrollment  
15 Ordinance; give notice of this Council's determination in accordance  
16 with Section 4 of Article III of the Papago Tribe Enrollment  
17 Ordinance; and place the names of each applicant upon the Tribal  
18 Membership Roll in accordance with Article V of the Papago Tribe  
19 Enrollment Ordinance.

20 The foregoing Resolution was duly enacted by the Papago Council on the 4th  
21 day of February, 1981, at a meeting at which a quorum was present with a  
22 vote of 965. for; 0 against; 0 not voting; and 1 absent,  
23 pursuant to the authority vested in the Papago Council by Article II and  
24 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe  
of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and  
approved by the Secretary of the Interior on January 6, 1937, pursuant to  
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
not subject to review by the Secretary of the Interior and is effective as  
of the date of its enactment by the Papago Council.
