

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Appointing a Committee of Three Volunteer )  
(Council Members to Review Liquor Ordinance)

RES. NO. 125-81

1 WHEREAS, the Papago Council is looking for alternate sources of revenue  
2 to support tribal programs; and

3 WHEREAS, the legalization, sale and taxation of alcoholic beverages on  
4 the Papago Reservation may be a source for such additional  
5 revenues; and


6 WHEREAS, the Papago Council has had a proposed liquor ordinance under  
7 review but has yet failed to act thereon; and

8 WHEREAS, it would be a benefit to the Council to have the proposed  
9 ordinance reviewed by a committee of Council members,


10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
11 appoint a committee of three (3) Council members, consisting of  
12 John Narcho, Harriet Toro and Andrew Patricio, to review the  
13 proposed liquor ordinance, and within two months, to bring to  
14 the Council any recommendations it may have concerning any  
15 amendment, implementation, and/or enactment of an ordinance  
16 governing the consumption, distribution and sale of alcoholic  
17 beverages on the Papago Reservation.

18 The foregoing Resolution was duly enacted by the Papago Council on the 18th  
19 day of September, 1981, at a meeting at which a quorum was present with a vote  
20 of 646.0 for; 374.0 against; 128.0 not voting; and 1 absent,  
21 pursuant to the authority vested in the Papago Council by Section 2 (e) and  
22 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona  
as amended, ratified by the Papago Tribe on December 12, 1936, and approved  
by the Secretary of the Interior on January 6, 1937, pursuant to Section 16  
of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
review by the Secretary of the Interior and is effective as of the date of its  
enactment by the Papago Council.
