RESOLUTION OF THE PAPAGO TRIBAL COUNCIL (Withholding Future Cost of Living) (and Merit Step Pay Increases)

RES. NO. 140-81

1 WHEREAS, in review and adoption or approval of FY 1982 budgets for 2 tribally funded programs and FY 1982 federally funded programs 3 grants and contracts of the Papago Tribe, the Papago Council 4 decided to withhold cost of living and merit step pay increases 5 because of the anticipated reductions both in general revenues 6 to the Tribe and in federal appropriations to fund tribal 7 programs; and WHEREAS, the Personnel Policies of the Papago Tribe mandate an annual 8 review and adoption of a compensation plan for employees of the 9 10 Papago Tribe and it is necessary in the meantime formally to 11 state the decision of the Papago Council to withhold cost of 12 living and merit step pay increases for tribal employees. 13 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, because of 14 anticipated reductions in the 1982 fiscal year in tribal 15 revenues and federal appropriations which will adversely affect 16 and reduce tribally operated programs, it is hereby ordered that 17 there will be no cost of living or merit step pay increases for employees of the Papago Tribe until further order of the Papago 18 Council. 19 The foregoing Resolution was duly enacted by the Papago Council on the 5th 20 day of November, 1981, at a meeting at which a quorum was present with a vote of 657.5 for; 376.0 against; 114.5 not voting; and 0 absent, pursuant to the authority vested in the Papago Council by Section 2 (e), (f) and (h) and Section 3 (a) and (h) of Article V of the Constitution and By-laws 21 of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 23 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is 24 effective as of the date of its enactment by the Papago Counci. 25 THE PAPAGO COUNCIL 26 27
